The Planning Commission is responsible for creating a master plan for the physical development of the City; prepares comprehensive programs for capital improvements; reviews rezoning requests, site plans, subdivisions, special use permits and other land use applications; reviews the widening and extension of streets, the development of parks and other public improvements; develops new zoning standards; and ensures that the standards of appropriate environmental protection legislation are applied. The Commission consists of nine members who serve three-year terms and meet twice monthly.
