East Lansing Planning Commission

The Planning Commission is responsible for creating a master plan for the physical development of the city; preparing comprehensive programs for capital improvements; reviewing rezoning requests, site plans, subdivisions, special use permits and other land use applications; reviewing the widening and extension of streets, the development of parks and other public improvements; developing new zoning standards; and ensuring that the standards of appropriate environmental protection legislation are applied. The Commission consists of nine members who serve three-year terms and meet twice monthly. View Planning Commission By-Laws (PDF ^[2]).
